A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County – Director of the Department of Social Services –**
3 **Pension and Retirement Health Benefits**

4 **MC 711-07**

5 FOR the purpose of allowing an individual, who is an employee of the Department of
6 Social Services in Montgomery County, and subsequently is transferred into the
7 State Personnel Management System, to remain in the Montgomery County
8 Retirement System or transfer into the Employees’ Pension System of the State
9 of Maryland; requiring the Central Payroll Bureau to deduct a certain amount
10 from the biweekly salary of the employee; requiring that the Department of
11 Human Resources provide the County with certain funding on a quarterly basis;
12 providing for the calculation and payment of these funds; providing for the
13 payment of employee and retiree health benefits; conditioning the payment of
14 employee and retiree health benefits on the payment by the State of a certain
15 contribution; providing for the effective date of certain provisions of this Act;
16 providing for the termination of certain provisions of this Act; and generally
17 relating to the pension and retirement benefits paid to the Director of the
18 Department of Social Services in Montgomery County who transfers into the
19 State Personnel Management System.

55 appointed on or after October 1, 1992, shall be in the executive service or management
56 service of the State Personnel Management System.

59 management service of the State Personnel Management System.

180 participant in the Anne Arundel County Retirement and Pension System; and

181 (iii) remains as an employee of the Child Support Enforcement

- 316 (ii) was employed by the New Community College of Baltimore
317 on or before December 31, 1990, as a “Class A” member of the Baltimore City
318 Retirement Plan; and
- 319 (iii) elected to remain a member of the Baltimore City
320 Retirement Plan;
- 321 (7) an employee who is not a member of a State system and who
322 accepts a position for which the budgeted hours per fiscal year are less than 500 hours
323 in the first fiscal year of employment; [or]
- 324 (8) an employee of the Domestic Relations Division of the Anne
325 Arundel County Circuit Court who:
- 326 (i) was transferred on or after July 1, 2002, into the State
327 Personnel Management System as an employee of the Child Support Enforcement
328 Administration of the Maryland Department of Human Resources;
- 329 (ii) elected, under § 2–510 of the Courts Article, to remain as a
330 participant in the Anne Arundel County Retirement and Pension System; and

331 (iii) remains as an employee of the Child Support Enforcement
332 Administration of the Maryland Department of Human Resources or an attorney
333 employed to represent the Child Support Enforcement Administration; [or]

334 (9) a nonfaculty employee of the Baltimore City Community College
335 who is eligible to participate and elects to participate in an optional retirement
336 program under Title 30 of this article; **OR**

337 **(10) THE DIRECTOR OF THE LOCAL BOARD OF SOCIAL SERVICES**
338 **IN MONTGOMERY COUNTY WHO:**

339 **(I) WAS TRANSFERRED INTO THE STATE PERSONNEL**
340 **MANAGEMENT SYSTEM AS AN EMPLOYEE OF THE SOCIAL SERVICES**
341 **ADMINISTRATION OF THE MARYLAND DEPARTMENT OF HUMAN RESOURCES;**

342 **(II) ELECTED, UNDER § 3-403.1 OF THE HUMAN SERVICES**
343 **ARTICLE, TO REMAIN AS A PARTICIPANT IN THE MONTGOMERY COUNTY**
344 **EMPLOYEES' RETIREMENT SYSTEM; AND**

345 **(III) REMAINS AS AN EMPLOYEE OF THE SOCIAL SERVICES**
346 **ADMINISTRATION OF THE MARYLAND DEPARTMENT OF HUMAN RESOURCES.**

347 SECTION 3. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall
348 take effect on the taking effect of Chapter ____ (S.B. 6) of the Acts of the General
349 Assembly of 2007. If Section 2 of this Act takes effect, Section 1 of this Act shall be
350 abrogated and of no further force and effect.

351 SECTION 4. AND BE IT FURTHER ENACTED, That, subject to the provisions
352 of Section 3 of this Act, this Act shall take effect July 1, 2007.
