4 FOR the purpose of altering an interest rate on certain judgments for the Washington  
5 Suburban Sanitary Commission; making a stylistic change; providing for the  
6 application of this Act; and generally relating to interest rates on judgments of  
7 the Washington Suburban Sanitary Commission.

8 BY repealing and reenacting, with amendments,

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Courts and Judicial Proceedings**

17           (a)    **(1)**    Except as provided in § 11–106 of this subtitle **AND PARAGRAPH**  
18 **(2) OF THIS SUBSECTION**, the legal rate of interest on a judgment shall be at the rate  
19 of 10 percent [per annum] **A YEAR** on the amount of judgment.

20                   **(2)**    **THE LEGAL RATE OF INTEREST ON A MONEY JUDGMENT FOR**  
21 **THE WASHINGTON SUBURBAN SANITARY COMMISSION SHALL BE AT THE RATE**  
22 **OF THE WEEKLY AVERAGE 2–YEAR CONSTANT MATURITY TREASURY YIELD, AS**  
23 **PUBLISHED BY THE BOARD OF GOVERNORS OF THE FEDERAL RESERVE**  
24 **SYSTEM, FOR THE CALENDAR WEEK PRECEDING THE DATE OF THE ENTRY OF**  
25 **JUDGMENT, COMPUTED DAILY TO THE DATE OF PAYMENT AND COMPOUNDED**  
26 **ANNUALLY.**

27           (b)    The legal rate of interest on a money judgment for rent of residential  
28 premises shall be at the rate of 6 percent [per annum] **A YEAR** on the amount of the  
29 judgment.

30           (c)    The legal rate of interest on a money judgment for delinquent real or  
31 personal property taxes shall be the greater of:

32                   (1)    The sum of the rates fixed under §§ 14–603 and 14–702 of the Tax  
33 – Property Article for interest and penalties; or

34                   (2)    At the rate of 10 percent [per annum] **A YEAR.**

35           SECTION 2. **AND BE IT FURTHER ENACTED**, That this Act shall be  
36 construed to apply only prospectively and may not be applied or interpreted to have  
37 any effect on or application to any judgment of the Washington Suburban Sanitary  
38 Commission entered before the effective date of this Act.

39           SECTION 3. **AND BE IT FURTHER ENACTED**, That this Act shall take effect  
40 October 1, 2007.
