1 AN ACT concerning

2 **Washington Suburban Sanitary Commission – Reciprocal Plumber/Gasfitter**  
3 **Licenses**

4 **MC/PG 109–07**

5 FOR the purpose of authorizing the Washington Suburban Sanitary Commission to  
6 issue a plumber/gasfitter license to a plumber/gasfitter who lives outside the  
7 sanitary district who holds a certain plumber/gasfitter license issued by the  
8 State Plumbing Board; and generally relating to the issuing of plumber/gasfitter  
9 licenses by the Washington Suburban Sanitary Commission.

10 BY repealing and reenacting, with amendments,  
11 Article 29 – Washington Suburban Sanitary District

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That the Laws of Maryland read as follows:

19 (a) Subject to § 12–305 of the Business Occupations and Professions Article,  
20 the WSSC has the sole power to grant licenses to persons desiring to work at the  
21 plumbing business in areas of Montgomery or Prince George’s County that are under  
22 the jurisdiction of the WSSC. The fees to be charged for a license may not exceed the  
23 fees as fixed in the Maryland Plumbing Act. The WSSC shall exercise within areas  
24 under the jurisdiction of the WSSC all the authority and power conferred upon the  
25 State Board of Plumbing.

26 (b) Any person holding a valid master [plumber’s] **PLUMBER/GASFITTER**  
27 license or a journeyman [plumber’s] **PLUMBER/GASFITTER** license issued by the  
28 WSSC is entitled to be issued a master [plumber’s] **PLUMBER/GASFITTER** license or  
29 a journeyman [plumber’s] **PLUMBER/GASFITTER** license, as applicable, by the State  
30 Board of Plumbing without examination, upon the presentation of a valid master  
31 [plumber’s] **PLUMBER/GASFITTER** license or a journeyman [plumber’s]  
32 **PLUMBER/GASFITTER** license, as applicable, and a notarized statement of good  
33 standing issued by the WSSC. Further, any [plumber residing in an area under the  
34 jurisdiction of the WSSC] **PLUMBER/GASFITTER** holding a valid master [plumber’s]  
35 **PLUMBER/GASFITTER** license or a [journey] **JOURNEYMAN** [plumber’s]  
36 **PLUMBER/GASFITTER** license issued by the State Board of Plumbing is entitled to be  
37 issued a master [plumber’s] **PLUMBER/GASFITTER** license or a journeyman  
38 [plumber’s] **PLUMBER/GASFITTER** license, as applicable, by the WSSC, without  
39 examination, upon presentation of a valid master [plumber’s] **PLUMBER/GASFITTER**  
40 license or a [journey] **JOURNEYMAN** [plumber’s] **PLUMBER/GASFITTER** license, as  
41 applicable, issued by the State Board of Plumbing.

42 (c) Any license issued to a master [plumber] **PLUMBER/GASFITTER** or a  
43 [plumber] **JOURNEYMAN PLUMBER/GASFITTER** in good standing pursuant to a  
44 reciprocity arrangement by the State Board of Plumbing and the WSSC prior to July  
45 1, 1978 shall remain in full force and effect.

46 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
47 October 1, 2007.
