A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County – Voting Methods**

3 **MC 29–19**

4 FOR the purpose of authorizing the Montgomery County Council to adopt, by law, a ranked
5 choice voting method or approval voting method for elections for certain local offices;
6 defining “ranked choice voting” and “approval voting”; authorizing a local law
7 adopting ranked choice voting or approval voting to provide for the ballot format,
8 procedures for tabulating votes, and other provisions necessary to implement ranked
9 choice voting or approval voting; and generally relating to the use of ranked choice
10 voting or approval voting for elections for local offices in Montgomery County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Election Law**

2 (a) Under the supervision of the State Board, and in accordance with regulations
3 and procedures adopted by the State Board, a local board shall conduct all elections held
4 under this article in the county in which the board is located.

5 (b) Except where it would be inappropriate, or as otherwise provided in this
6 article, the electoral process for primary elections, general elections, and special elections
7 shall be uniform.

8 (c) (1) (i) **IN THIS SUBSECTION THE FOLLOWING WORDS HAVE THE**
9 **MEANINGS INDICATED.**

10 (ii) **“APPROVAL VOTING” MEANS A METHOD OF CASTING AND**
11 **TABULATING VOTES IN WHICH VOTERS MAY CHOOSE ANY NUMBER OF CANDIDATES**
12 **AND THE CANDIDATE CHOSEN MOST OFTEN IS ELECTED.**

13 (iii) **“RANKED CHOICE VOTING” MEANS A METHOD OF CASTING**
14 **AND TABULATING VOTES IN WHICH VOTERS RANK CANDIDATES IN ORDER OF**
15 **PREFERENCE AND VOTES ARE TABULATED IN A MANNER THAT REFLECTS VOTER**
16 **PREFERENCE.**

17 (2) **THE MONTGOMERY COUNTY COUNCIL MAY, BY LAW, ADOPT A**
18 **RANKED CHOICE VOTING SYSTEM OR AN APPROVAL VOTING SYSTEM FOR ELECTIONS**
19 **FOR THE FOLLOWING OFFICES:**

20 (i) **COUNTY EXECUTIVE;**

21 (ii) **MEMBER OF THE COUNTY COUNCIL;**

22 (iii) **JUDGE OF THE CIRCUIT COURT;**

23 (iv) **STATE’S ATTORNEY;**

24 (v) **CLERK OF THE CIRCUIT COURT;**

25 (vi) **REGISTER OF WILLS;**

1 (VII) JUDGE OF THE ORPHANS' COURT;

2 (VIII) SHERIFF; AND

3 (IX) MEMBER OF THE BOARD OF EDUCATION.

4 (3) A LOCAL LAW ENACTED UNDER THIS SUBSECTION MAY PROVIDE
5 FOR:

6 (I) THE BALLOT FORMAT;

7 (II) PROCEDURES FOR TABULATING VOTES; AND

8 (III) ANY OTHER PROVISION NECESSARY TO IMPLEMENT
9 RANKED CHOICE VOTING OR APPROVAL VOTING.

11 (a) Subject to the other provisions of this subtitle and to different presentations
12 required or made desirable by different voting systems, all ballots used in an election shall
13 be as uniform as possible.

14 (b) Except as otherwise specifically provided in this title, or unless a provision is
15 clearly inappropriate to absentee ballots, the provisions of this subtitle relating to ballot
16 content and arrangement shall apply to the arrangement of absentee ballots.

17 (c) If applicable for the voting system in use, the appropriate components of the
18 voting system shall be configured for a primary election to permit the voter to vote only for
19 the candidates for which the voter is entitled to vote.

20 (D) THE MONTGOMERY COUNTY COUNCIL MAY, BY A LAW ADOPTED IN
21 ACCORDANCE WITH § 8-101(C) OF THIS ARTICLE, PROVIDE FOR THE FORMAT OF
22 BALLOTS TO BE USED IN AN ELECTION CONDUCTED BY RANKED CHOICE VOTING OR
23 APPROVAL VOTING.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
25 1, 2019.
