1 AN ACT concerning

2 **Montgomery County – Damascus – Alcoholic Beverages Licenses**

3 **MC 9–19**

4 FOR the purpose of repealing in Montgomery County a provision regarding the issuance of
5 licenses in country inn zones in Damascus; repealing a restriction on the number of
6 Class H licenses that may be issued in Damascus by the Board of License
7 Commissioners for Montgomery County; and generally relating to alcoholic
8 beverages licenses in Montgomery County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Alcoholic Beverages**

4 25–102.

5 This title applies only in Montgomery County.

6 25–1603.

7 (a) This section applies only to Damascus (12th election district).

8 (b) [The Board may issue not more than two licenses with an on–sale privilege
9 for restaurants in the country inn zone of the county.

10 (c) The Board may issue a 7–day Class C (on–sale) beer, wine, and liquor license
11 to a volunteer fire department.

12 [(d)] (C) (1) Subject to [subsection (b) of this section and] paragraph (2) of
13 this subsection:

14 (i) the Board may issue [not more than two] Class H beer and wine,
15 hotel and restaurant licenses; and

16 (ii) the licenses may be renewed or transferred.

17 (2) A license may be issued, transferred, or renewed if:

18 (i) pool tables, billiard tables, shuffleboards, dart boards, video
19 games, pinball machines, or recreational devices are not used in the licensed premises; and

20 (ii) alcoholic beverages served by the license holder are consumed by
21 customers while the customers are seated.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
23 1, 2019.
