A BILL ENTITLED

1 AN ACT concerning

2 **Property Tax Credits – Maryland–National Capital Park and Planning**
3 **Commission Park Police Officers**

4 **MC/PG 108–19**

5 FOR the purpose of altering the definition of “public safety officer” to include certain park
6 police officers who are employed by the Maryland–National Capital Park and
7 Planning Commission for purposes of a certain property tax credit; providing for the
8 application of this Act; and generally relating to property tax credits and park police
9 officers of the Maryland–National Capital Park and Planning Commission.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Tax – Property**

2 (a) (1) In this section the following words have the meanings indicated.

3 (2) “Dwelling” has the meaning stated in § 9–105 of this title.

4 (3) “Public safety officer” means:

5 (i) a firefighter, an emergency medical technician, a correctional
6 officer, a police officer, or a deputy sheriff employed full time by a public safety agency in
7 the county or municipal corporation where the individual resides; [or]

8 (ii) a volunteer firefighter for a public safety agency in the county or
9 municipal corporation where the individual resides; **OR**

10 **(III) A PARK POLICE OFFICER EMPLOYED FULL TIME BY THE**
11 **MARYLAND–NATIONAL CAPITAL PARK AND PLANNING COMMISSION WHO RESIDES**
12 **IN MONTGOMERY COUNTY OR PRINCE GEORGE’S COUNTY.**

13 (b) The governing body of a county or municipal corporation may grant, by law, a
14 property tax credit under this section against the county or municipal corporation property
15 tax imposed on a dwelling located in the county or municipal corporation that is owned by
16 a public safety officer if the public safety officer is otherwise eligible for the credit
17 authorized under § 9–105 of this title.

18 (c) In any taxable year, the credit under this section may not exceed the lesser of:

19 (1) \$2,500 per dwelling; or

20 (2) the amount of property tax imposed on the dwelling.

21 (d) The governing body of a county or a municipal corporation may establish, by
22 law:

23 (1) subject to subsection (c) of this section, the amount of the credit under
24 this section;

25 (2) the duration of the credit;

- 1 (3) additional eligibility requirements for public safety officers to qualify
- 2 for the credit;

- 3 (4) procedures for the application and uniform processing of requests for
- 4 the credit; and

- 5 (5) any other provisions necessary to carry out this section.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June

7 1, 2019, and shall be applicable to all taxable years beginning after June 30, 2019.
