1 AN ACT concerning

2 **Montgomery County – Wireless Telecommunications Towers – Prohibition on**
3 **Public Elementary and Middle School Grounds**

4 **MC 811-08**

5 FOR the purpose of prohibiting the siting of wireless telecommunications towers on
6 certain public school property in Montgomery County; providing for the
7 application of this Act; providing that existing obligations or contract rights may
8 not be impaired by this Act; and generally relating to wireless
9 telecommunications towers and the use of public school property in Montgomery
10 County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article – Education**

20 (a) All property granted, conveyed, devised, or bequeathed for the use of a
21 particular public school or school system:

22 (1) Except as provided in subsection (c) of this section, shall be held in
23 trust for the benefit of the school or school system by the appropriate county board or,
24 for real property in Baltimore City, by the Mayor and City Council of Baltimore; and

25 (2) Is exempt from all State and local taxes.

26 (b) Money invested in trust for the benefit of the public schools for any
27 county or city is exempt from all State and local taxes.

28 (c) (1) A private entity may hold title to property used for a particular
29 public school or local school system if the private entity is contractually obligated to
30 transfer title to the appropriate county board on a specified date.

31 (2) The conveyance of title of school property to a private entity for a
32 specified term under this subsection may not be construed to prohibit the allocation of
33 construction funds to an approved school construction project under the Public School
34 Construction Program.

35 (3) A county or county board may convey or dispose of surplus land
36 under the jurisdiction of the county or county board in exchange for public school
37 construction or development services.

38 **(D) (1) THIS SUBSECTION APPLIES TO PROPERTY GRANTED,**
39 **CONVEYED, DEVISED, OR BEQUEATHED FOR THE USE OF THE MONTGOMERY**
40 **COUNTY PUBLIC SCHOOL SYSTEM.**

41 **(2) NOTWITHSTANDING SUBSECTION (C) OF THIS SECTION, THE**
42 **GROUNDS OF AN ELEMENTARY OR MIDDLE SCHOOL IN MONTGOMERY COUNTY**
43 **MAY NOT BE USED AS A SITE FOR A WIRELESS TELECOMMUNICATIONS TOWER.**

44 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
45 construed to apply only prospectively and may not be applied or interpreted to have
46 any effect on or application to any wireless telecommunications tower in Montgomery
47 County in existence or for which all necessary permits for construction have been
48 issued before the effective date of this Act. If the use of a wireless telecommunications
49 tower is allowed to continue in accordance with this section:

50 (1) the use may not be expanded; and

51 (2) if abandoned, the use may not be resumed.

52 SECTION 3. AND BE IT FURTHER ENACTED, That a presently existing
53 obligation or contract right may not be impaired in any way by this Act.

54 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect
55 June 1, 2008.
